



## BOOK ORDER FORM

This book, written and compiled by Dr. Corey Hilmas and Dr. Daniel Fabricant, alphabetically organizes a pre-DSHEA list of old dietary ingredients (ODIs) that were marketed and sold prior to October 15, 1994, the implementation date for the Dietary Supplement Health and Education Act (DSHEA) of 1994. These dietary ingredients would be exempt from filing notifications with FDA as New Dietary Ingredients (NDIs). The ingredient names contain reference citations to the original printed source material, which consists of NPA's own printed magazines and newsletters over the decades. The listing also includes ingredients submitted as GRAS notices to FDA with no further comment by the Agency. As there has not yet been an authoritative list of ODIs, this will be the first pre-DSHEA ODI list to be published and available to the public with independent and verifiable evidence.
